The Council considered a request from Ronald Kreikemeier and Linda Kreikemeier for parking stalls on the public right-of-way at their property at 105 N. Oak Street. Following discussion, it was moved by Hugo, seconded by Swenson, to approve the request of Ronald Kreikemeier and Linda Kreikemeier to pave parking stalls at 105 N. Oak Street. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The next agenda item was the use of Eminent Domain to acquire the property located at the W 1/2 of Lots 5 and 6, in Block 47, in the Original Plat of the City of West Point, Cuming County, Nebraska (House located at 130 E. Sheridan St.) owned by Frat Order of Eagles. After discussion, Smith made a motion to offer original agreement with exception of a 12' foot easement with equal amount of ground (240 sq ft) to be added onto the north end of the lot with all other terms as of last offer and as discussed, seconded by Stokely. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Tina Biteghe Bi Ndong, Executive Director of the West Point Chamber of Commerce, appeared before the Council and presented the quarterly report on the Chamber's economic development activities. It was moved by Smith and seconded by Buse to accept the report and approve the payment of \$5,000 for services January-March, 2023. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The City Administrator presented the Council with an opportunity for additional generation and capacity. There are Units for sale that have the capability to produce two megawatts of power. Each unit is priced at approximately \$300,000.00. Following discussion, it was moved by Smith, seconded by Buse, to move forward hiring an Electrical Engineer and contracting with JEO. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The City Administrator then presented the Council with the 2023 Tax Increment Financing (TIF) Annual Report. The report showed the progress of the redevelopment projects that were financed in whole or in part through TIF. This report will also be given to the taxing entities affected by such division of taxes. It was moved by Swenson and seconded by Smith to accept the 2023 Tax Increment Financing Annual Report. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Morrow, Davies & Toelle, P.C (Cruise & Associates) has prepared the City's Audited Financial Statements for the fiscal year ending September 30, 2022 and each councilmember was provided a copy. In the absence of hard copies being available, this matter was tabled until next meeting.

The Council considered approval of the Early Redemption and Prepayment of the Outstanding Refunding Certificates on the Nielsen Center. Stokely introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA AUTHORIZING THE EARLY REDEMPTION AND PREPAYMENT OF THE OUTSTANDING REFUNDING CERTIFICATES OF PARTICIPATION (WEST POINT, NEBRASKA COMMUNITY CENTER PROJECT) SERIES 2017.

Hugo seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

Moved by Buse, seconded by Swenson, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$26,074.29. Voting Yea: Stokely, Penrose, Swenson, Buse, and Smith. Nay: None. Abstaining: Hugo. Motion carried.

Moved by Swenson, seconded by Smith, to approve the application for Special Designated Liquor Permit for Graybeal's Food for the West Point Beemer Alumni Banquet on May 27, 2023. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The Council considered the request from the Cattlemen's Ball Committee for use of city streets for a Cattlemen's Ball Stampede Fun Run on June 3, 2023. The proposed route was reviewed. Moved by Smith and seconded by Swenson to approve the request for use of city streets for a Cattlemen's Ball Stampede Fun Run on June 3, 2023. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Smith introduced the following resolution and moved its adoption:

BE IT RESOLVED BY THE MAYOR AND COUNCIL of the City of West Point, Nebraska, to approve Application/Payment No. 5 in the amount of \$113,892.96 to Christiansen Construction Company for the West Point Aquatic Center Project and authorize the City Clerk to make payment.

Penrose seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith.

Nay: None. Motion carried and said resolution adopted.

The City Administrator then announced the following:

- 1. LOCAL will be doing a grand opening at end of April. They will have an ice cream truck in front of their business for the event.
- 2. CCCFF grants applied for the pool were rejected. The planning grant for the rec center was approved.

Moved by Swenson, seconded by Buse, to adjourn at 6:06 P.M. Voting Yea: Stokely,
