MINUTES OF MEETING

The Mayor opened a public hearing on determining a nuisance to be found at 1140 West Park Street. The City Administrator stated that the property owner had been given a permit to add living quarters to the storage building to conform to residential zoning. No progress has been made. Following discussion, Smith introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF WEST POINT, NEBRASKA, DETERMINING A NUISANCE TO BE FOUND AT 1140 WEST PARK STREET AND DIRECTING ABATEMENT OF SAME.

Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo and Smith.

Nay: None. Motion carried and said resolution adopted.

The Council then considered the bids for the catered meals at the Senior Citizens Center. The only bid received was from St. Joseph's Elder Services, Inc. with the cost per meal increasing to \$8.25. The current cost is \$7.75. Following discussion, Buse introduced the following resolution and moved its adoption:

BE IT RESOLVED BY THE MAYOR AND COUNCIL of the City of West Point, Nebraska, to accept the bid of St. Joseph's Elder Services, Inc. to provide catered meals for the Senior Citizens Center at a rate of \$8.25 per meal for the period from July 1, 2023 to June 30, 2024.

Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

Tom Stratman, Fire Chief, gave the annual report for the West Point Volunteer Fire Department. Fire department consists of 39 members. They had approximately 1500 training hours. He reported they responded to 116 calls. Calls were up from 91 the previous year. The calls consisted of 31 car accidents; 29 grass/field fires; 26 false alarms; 15 hazardous calls; 6 car fires; and 1 bin rescue. They had approximately 2100 service hours.

Roger Paus of the Road Gems, appeared before the Council concerning the West Point Car Show which will be on Sunday, September 17, 2023. Their request was as follows:

- 1. That the Road Gems have control of the Nielsen Center and surrounding streets and parking lots, including Anna Stalp Avenue, 2 blocks of north Mill Street and the paved roads on the eastern portion of Neligh Park.
- 2. The closing of Anna Stalp Avenue from Main Street to Neligh Park, Mill Street from Bridge Street to Washington Street, Decatur Street from the alley to Mill Street and the park roads from the swimming pool to Washington Street.
- 3. That Road Gems have control of the vending and sales within these event areas.
- 4. That the City provide portable toilets for the event (up to \$1,000.00)
- 5. That the City provide financial assistance to promote the car show in the amount of \$2,500.00.

Following discussion, it was moved by Swenson and seconded by Smith to approve the request of the Road Gems for the West Point Car Show on September 17, 2023. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The Council considered the request from West Point Chamber of Commerce for the City's continued assistance for the annual July 4th fireworks display. Tina from the Chamber made a suggestion that going forward the donation go directly to the Volunteer Fire Department. The

request was for \$5,000.00. Stokely moved to contribute the amount of \$5,000 for the July 4th fireworks display and Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

MDT, LLC (Cruise & Associates) has prepared the City's Audited Financial Statements for the fiscal year ending September 30, 2022 and each councilmember was provided a copy. It was moved by Buse, seconded by Smith, to acknowledge receipt of the audit. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Next the Council considered the adjustment to water rate schedule. The City Administrator stated that the average user would see a \$1.68 to \$1.76 per month increase. Following lengthy discussion, Buse introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA ESTABLISHING WATER SERVICE RATE SCHEDULES PURSUANT TO SECTION 6-208 OF THE MUNICIPAL CODE OF THE CITY OF WEST POINT; FIXING DATES FOR PAYMENT; PROVIDING FOR DISCONTINUANCE OF SERVICE FOR DELINQUENCY; FIXING RECONNECTION CHARGES; AND REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS RESOLUTION.

Hugo seconded the motion. Voting Yea: Swenson, Buse, Hugo and Smith. Nay: Stokely and Penrose. Motion carried and said resolution adopted.

The July and August Council meetings are rescheduled from Tuesday, July 4th to Wednesday, July 5th and Tuesday, August 1st to Monday, August 7th with the time remaining at 5:30 PM. It was moved by Smith and seconded by Penrose to approve the date changes. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The City Administrator advised the Council concerning the Interlocal Agreement between the City of West Point and the City of Oakland for use of Oakland's swimming pool for the 2023 season. Following discussion, Swenson introduced the following resolution and moved its adoption:

A RESOLUTION OF THE CITY OF WEST POINT, NEBRASKA, APPROVING THE INTERLOCAL COOPERATION AGREEMENT WITH THE CITY OF OAKLAND, NEBRASKA, FOR USE OF OAKLAND'S SWIMMING POOL.

Penrose seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith.

Nay: None. Motion carried and said resolution adopted.

The Council was informed with the renewal in the League Insurance Government Health Team (LIGHT) the City would see an increase of 4.04% and still be with Blue Cross Blue Shield and the ancillary insurance with Mutual of Omaha should not see a change until 2025. Following discussion, it was moved by Smith and seconded by Buse to approve renewal. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried

Moved by Smith, seconded by Stokely, to approve the following applications for Special Designated Liquor Permits:

- (a) GACC JayFest Fundraiser on June 9, 2023 at Nielsen Center.
- (b) Rush's for the GACC Alumni Banquet on June 10, 2023 at Nielsen Center.
- (c) Cuming County Ag Society for August 10-13, 2023 Cuming County Fair (Neligh Park & Fairgrounds).
- (d) Cuming County Ag Society for August 13, 2023 Fair events to be held at Nielsen Community Center.
- (e) Cuming County Ag Society for August 12, 2023 Fair event to be held at Anderson Ballfield.

Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Swenson, seconded by Smith, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$15,657.14. Voting Yea: Stokely, Penrose, Swenson, Buse, and Smith. Nay: None. Abstaining: Hugo. Motion carried.

Earl Boston appeared before the Council with comments and questions regarding the possible purchase of electrical generators, West Point electrical rates and the status report on dike upgrade and estimated completion date.

Smith introduced the following resolution and moved its adoption:

BE IT RESOLVED BY THE MAYOR AND COUNCIL of the City of West Point, Nebraska, to approve Application/Payment No. 6 in the amount of \$295,026.16 to Christiansen Construction Company for the West Point Aquatic Center Project and authorize the City Clerk to make payment.

Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

The City Administrator reported that flushing of the water lines would start on May 8th starting on the low side and working to the high side. Council members also discussed areas in the City that have issues or improvement including the website; areas on the Highway; Colfax,

Bridge, and Neligh Streets; and issues with semis parking on the empty JDs lot and leaving their engines running in the overnight hours.

Moved by Swenson, seconded by Smith, to adjourn at 6:38 P.M. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.
