The Mayor opened a public hearing on the 1 Year & 6 Year Street Improvement Program. Terry Schulz, Advanced Consulting Engineering Services, appeared before the Council to review the 1 & 6 year street improvement program. The one year plan is basically maintenance which includes the intersection of Neligh Street and Colfax Street and Colfax Street from Bridge Street to Park Street. The six-year plan includes paving of 18th Road from Washington Street south to Hwy 32; Colfax Street from 13th Street to Plaza Drive; Pine Street from Oak Street to Maple Street; and Sherman Street from Bruner Street to Beemer Street. After discussion, it was moved by Stokely and seconded by Buse to approve the 1 Year and 6 Year Street Improvement Plan as presented. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.

Next the Council considered a request from Brent and Kari Simonsen to split a tract of land located partially in Lot 2, Spring Lake Addition and partially in Schmader's Second Addition to the City of West Point, Cuming County, Nebraska. The City Administrator explained that it is a simple lot split to close the rear property line. Stokely introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA TO APPROVE THE SUBDIVISION OF REAL ESTATE LOCATED WITHIN THE CITY OF WEST POINT, AND WITHIN THE ZONING JURISDICTION OF SAID CITY, CUMING COUNTY, NEBRASKA.

Hugo seconded the motion. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent:

Penrose and Smith. Motion carried and said resolution adopted.

Next the Council considered request from Ruth Schmaderer to split a tract of land located in the South 8 feet of the North 58 feet of said Lot 3, in Block 93, in the Original Plat, also described as being in Neligh's Addition, to the City of West Point, Cuming County, Nebraska. The City Administrator explained that it is a simple lot split adding 8 foot back to the property. Swenson introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA TO APPROVE THE SUBDIVISION OF REAL ESTATE LOCATED WITHIN THE CITY OF WEST POINT, CUMING COUNTY, NEBRASKA

Buse seconded the motion. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried and said resolution adopted.

The Council then considered the request from the West Point Optimists for a reduced rate

for use of one-fourth of the Nielsen Community Center for the Clothing Community-Share Project on

November 7 & 8, 2023. This is the same request as the last several years and the Council previously

has reduced the rate to one-half of the regular rate. Following discussion, it was moved by Stokely, seconded by Swenson, to permanently waive the rental fee of the Nielsen Community Center during the two days only of the West Point Optimists Clothing Community-Share Project. The West Point Optimist will no longer have to come before the Council. They would coordinate directly with the Nielsen Community Center. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.

David Branch, Cuming County Economic Development Director, came before the Council to request a three-year commitment of funds for the Cuming and Burt County Transportation program in the amount of \$4,500 annually. Stokely, moved to contribute \$4,500 annually for three years to the Cuming and Burt County Transportation program, and Buse seconded the motion. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.

Kevin McElyea, Aquatic Design, and Chris Gilson, Christiansen Construction, appeared before the Council to give an update on the pool construction schedule. Christiansen Construction will be filing for an extension due to weather, equipment deliveries, manufacturing and material delays. Substantial completion date is looking like mid-April 2024. After the pool has been filled and training of City employees has taken place, it would be turned over to the City at that time.

In addition to approving a 1 Year & 6 Year Street Improvement Program, the City must also do an annual certification of program compliance. Swenson introduced a resolution that the Mayor of the City of West Point is hereby authorized to sign the Municipal Annual Certification of Program Compliance Form for the Nebraska Board of Public Roads Classifications and Standards. Hugo seconded the motion. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried and said resolution adopted.

Next was the six-month report on the LB 840 Economic Development program. The City Administrator presented the report stating that everything is on track for this program and there is approximately \$117,000.00 available. Currently, there are three pending applications.

Tina Biteghe Bi Ndong, Executive Director of the West Point Chamber of Commerce, appeared before the Council and presented the quarterly report on the Chamber's economic development activities. Moved by Hugo and seconded by Stokely to accept the report and approve the payment of \$5,000 for services July-September, 2023. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.

Moved by Swenson, seconded by Stokely, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$1,909.77. Voting Yea: Stokely, Swenson and Buse. Nay: None. Abstaining: Hugo. Absent: Penrose and Smith. Motion carried.

Buse introduced the following resolution and moved its adoption:

BE IT RESOLVED BY THE MAYOR AND COUNCIL of the City of West Point, Nebraska, to approve Application/Payment No. 12 in the amount of \$795,561.51 to Christiansen Construction Company for the West Point Aquatic Center Project and authorize the City Clerk to make payment.

Stokely seconded the motion. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried and said resolution adopted.

The next agenda item was to discuss the potential purchase of real estate. Moved by Stokely, seconded by Buse to go into closed session at 6:35 PM for the protection of the public interest to discuss the potential purchase of real estate. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried. The Mayor then restated for the record the limitation of the subject matter of the closed session was for the protection of the public interest to discuss the potential purchase of real estate. At 6:45 PM the Mayor stated that the closed session had ended and that the only item discussed during the closed session was the potential purchase of real estate and that the Council was back in regular session.

Moved by Stokely, seconded by Buse, to approve the purchase real estate across from the Nielsen Center in the amount of \$200,000. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.

Moved by Stokely, seconded by Swenson, to adjourn at 6:47 P.M. Voting Yea: Stokely, Swenson, Buse and Hugo. Nay: None. Absent: Penrose and Smith. Motion carried.
