A reorganizational meeting of the Mayor and Council of the City of West Point, Nebraska was held at the Municipal Building in said City. Present were: Mayor Schlecht; Councilmembers: Councilmember Stokely, Councilmember Penrose, Councilmember Swenson, Councilmember Buse, Councilmember Hugo, and Councilmember Smith.

Election of council president was held. Swenson nominated Councilmember Hugo. Moved by Stokely and seconded by Smith, that the nominations cease and that Councilmember Hugo be elected Council President. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried. The Mayor declared Councilmember Hugo to be the Council President. The Mayor announced his appointments to the standing committees as follows:

Moved by Swenson, seconded by Buse, to approve the designation of Charter West Bank

and F&M Bank as the official depositories of the City. Voting Yea: Stokely, Penrose, Swenson,

Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Buse, seconded by Swenson, to approve the designation of West Point News

as the official newspaper of the City. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and

Smith. Nay: None. Motion carried.

Moved by Swenson, seconded by Smith, to approve said appointments. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried. Chief of Police, John Adams, then introduced newly hired female officer, Jedzia Radke.

The City administrator then explained the two bids received in regard to the construction of the Canoe Launch Pad. The first one from Pruss Excavation in the amount of \$113,896 with an anticipated start date of April 30 2024 and a completion date of June 30 2024. The second bid was from Sawyer Construction Company in the amount of \$159,059 with the start date of April 1 2024 and a completion date of July 1 2024. The engineers original estimate was \$120,000. John with ACES did go through the tab sheets and they are recommending to award to Pruss Excavation in the amount of \$113,896. The City Administrator also mentioned that the NRD approved a \$30,000 grant for this project as well and we are well under the \$130,000 budget. Smith introduced a resolution that the bid for the Canoe Launch Pad by Pruss Excavation for \$113,896 is the lowest and best bid received; and that the Mayor and City Clerk are authorized to execute such contract documents as may be necessary to complete the award of the contract and to order the commencement of the work. Buse seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo and Smith. Nay: None. Motion carried and said resolution adopted.

Rick Wimer of Inspro Insurance reviewed with the Council the City's general insurance coverage/premium with Employers Mutual Casualty Insurance Companies. It was stated that the property values have increased slightly. It was moved by Smith and seconded by Stokely, to continue the City's insurance coverage with Employers Mutual Casualty Insurance Companies. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Next the Council considered a request from S2 Mitch Sawyer for the subdivision of a tract of land located in West Point Industrial Tract North, an Addition to the City of West Point, in Cuming County, Nebraska. The City Administrator advised that the Planning Commission had considered the matter and was forwarding a favorable recommendation. Smith introduced the following resolution and moved its adoption:

<u>A</u> RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA TO APPROVE THE SUBDIVISION OF REAL ESTATE LOCATED WITHIN THE CITY OF WEST POINT, CUMING COUNTY, NEBRASKA.

Stokely seconded the motion. Voting Yea: Stokely, Penrose, Buse, Hugo, and Smith. Nay: Swenson. Motion carried and said resolution adopted.

The City Administrator then proceeded to report, on behalf of the Economic Development Committee, the following LB 840 Economic Development applications:

1. BRIX Salon LLC requesting \$15,000.00 to clean up the store front. The Committee recommended a \$15,000.00 grant with a five-year term.

2. ASWS Properties requesting \$93,000.00 to construct a new facility. The Committee recommended \$45,000.00 with a \$22,500.00 grant and a \$22,500.00 loan with a five-year term.

It was moved by Hugo and seconded by Smith to approve the recommendations of the Economic Development Committee for the above loan and grant from the LB 840 Economic Development Funds as presented. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo and Smith. Nay: None. Motion carried.

The Council then considered the Annual Maintenance Agreement between the Nebraska Department of Transportation and the City relating to the responsibilities/maintenance of the highways within the municipality. There was a change in the lane miles being 4.16 lane miles or the cost per lane mile being \$1,545.00. Moved by Buse and seconded by Stokely to approve the Annual Maintenance Agreement for the period of January 1, 2024 to December 31, 2024. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Stokely and seconded by Smith to approve the City's agreement with Nebraska Veterinary Services for city pound services. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Smith and seconded by Swenson to approve a \$125 Holiday Bonus for City employees. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

City Administrator requested the February council meeting be moved to Thursday, February 1st. Moved by Stokely, seconded by Smith, to move February council meeting to February 1st. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Smith seconded by Buse, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$4,497.66. Voting Yea: Stokely, Penrose, Swenson, Buse, and Smith. Nay: None. Abstaining: Hugo. Motion carried. Moved by Swenson, seconded by Stokely, to approve the following applications for Special Designated Liquor Permits:

(a) Assumption of the Blessed Virgin Mary-St. Mary's Church for a Cornhole Tournament on January 5, 2024.

(b) Roadhouse Lounge for the 2-I Conference on January 24, 2024.

(c) Roadhouse Lounge for Ducks Unlimited Banquet on January 26, 2024.

Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Buse introduced the resolution to approve Application/Payment No. 14 in the amount of \$321,917.23 to Christiansen Construction Company for the West Point Aquatic Center Project and authorize payment. Smith seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo and Smith. Nay: None. Motion carried and said resolution adopted.

Moved by Smith, seconded by Swenson, to adjourn at 5:56 P.M. Voting Yea: Stokely,

Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.
