Moved by Hugo, seconded by Smith, to approve the designation of Charter West Bank, F & M Bank, and Wells Fargo Bank as the official depositories of the City. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Moved by Penrose, seconded by Swenson, to approve the designation of West Point News as the official newspaper of the City. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Moved by Swenson, seconded by Penrose to approve said appointments. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Next on the agenda was to discuss water services. Peggy Watson and Peggy Cooper appeared before the Council concerning Peggy Watson's water service line and the bill received from Hugo Plumbing & Heating for repairs. There was a water leak under the street by Peggy Watson's residence and when Hugo Plumbing & Heating proceeded to repair it, it was discovered that three customers were served from the one service line. The bill for the repairs was divided by three and sent to each customer. Ms. Watson was objecting the bill. Current code states that only one customer shall procure water from the same service or supply pipe, but 50-60 years ago, party lines were done. No action was taken.

Rick Wimer of Inspro Insurance reviewed with the Council the City's general insurance coverage/premium with Employers Mutual Casualty Insurance Companies. It was stated that the workers comp coverage had a slight decrease and that there were increases in the property and auto coverage, but overall, the premium is less than last year. Moved by Smith and seconded by Penrose, to continue the City's general property and casualty insurance coverage with Employers Mutual Casualty Insurance Companies. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

The Council was informed that at the residence of Doug Knobbe, being 624 E. Sherman Street, work was in progress of constructing parking stalls on the public right-of-way without approval. Mr. Knobbe was notified to stop the work but because of how far the project was, the City Administrator allowed him to finish. Mr. Knobbe was not aware that prior approval was needed. The Council did proceed to formally approve the parking. Moved by Hugo, seconded by Stokely, to allow the parking stalls on public right-of-way at the residence located at 624 E. Sherman Street. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Next the Council considered a request from Tyler Baumert – Plaza Car Wash, LLC to subdivide Lot 3, except the East 48 feet thereof, in West Point Travel Plaza Subdivision, into three tracts. The City Administrator advised that the Planning Commission had considered the matter and was forwarding a favorable recommendation. Penrose introduced a resolution that the division of Lot 3, (except the East 48 feet thereof), into the three tracts be and the same is hereby approved. Stokely seconded the motion. Voting Yea: Stokely, Penrose, Swenson, and Hugo. Nay: None. Abstaining: Smith. Absent: Buse. Motion carried and said resolution adopted.

With the release of the 2020 federal census numbers, cities that elect councilmembers by wards are required to redraw the ward lines to maintain substantial population equity. Swenson introduced Ordinance No. 1425 entitled:

AN ORDINANCE OF THE CITY OF WEST POINT, NEBRASKA ESTABLISHING THE BOUNDARIES OF THE MUNICIPAL ELECTION WARDS; AMENDING SECTION 1-613 OF THE MUNICIPAL CODE AND ORDINANCE NO. 1328 WHICH HAD PREVIOUSLY ESTABLISHED SUCH BOUNDARIES; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT, AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM,

and moved that the statutory rule requiring reading on three different days be suspended. Stokely seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried. Statutory rule suspended. Swenson moved for final passage of the ordinance, which motion was seconded by Smith. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Ordinance adopted.

The next agenda item was to discuss the annual employee holiday bonus. Swenson asked that this not be on the consent agenda but under current business for discussion. This bonus has been set at \$100.00 since 2017 and he felt it should be increased to \$125.00. Moved by Smith and seconded by Swenson to increase the annual employee holiday bonus to \$125.00. Voting Yea:

Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Swenson introduced a resolution that the Mayor of the City of West Point is hereby authorized to sign the Year-End Certification of City Street Superintendent form from by the Nebraska Department of Transportation. Hugo seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried and said resolution adopted.

The Council then considered the Annual Maintenance Agreement between the Nebraska Department of Transportation and the City relating to the responsibilities/maintenance of the highways within the municipality. There was no change from the previous year in the lane miles being 3.94 lane miles or the cost per lane mile being \$1,545.00. Moved by Smith and seconded by Swenson to approve the Annual Maintenance Agreement with the Nebraska Department of Transportation for the period of January 1, 2022 to December 31, 2022. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried

Smith introduced a resolution that the City of West Point is hereby authorized to join and cooperate with other countries, incorporated villages, and cities that are eligible and may wish to participate in the Northeast Nebraska Economic Development District through the execution of an Intergovernmental Agreement. Swenson seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried and said resolution adopted.

The Council considered the manager application submitted to the Nebraska Liquor Control Commission by Eagles Frat Order 3623 naming Chyanne Krause as manager. Moved by Swenson and seconded by Penrose to forward a favorable recommendation to the Nebraska Liquor Control Commission on this application. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Moved by Stokely, seconded by Penrose, to approve the following applications for Special Designated Liquor Permits under the Nebraska Liquor Control Act:

- (a) Assumption of the Blessed Virgin Mary for a Cornhole Tournament at the GACC Activities Center on January 14, 2022.
- (b) Roadhouse Lounge for the 2-I Conference at the Nielsen Community Center on January 26, 2022.

Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.

Moved by Swenson, seconded by Smith, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$1,480.39. Voting Yea: Stokely, Penrose, Swenson, and Smith. Nay: None. Abstaining: Hugo. Absent: Buse. Motion carried.

Stokely introduced a resolution a to approve Change Orders No. 1 and No. 2 and Payment No. 4 (final) to Elkhorn Paving Construction Co., Inc. for Phase IV of the West Point Trails and Pathways Project in the amount of \$16,826.52. Penrose seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried and said resolution adopted.

City Administrator and Councilmember Smith spoke to the Council about the City developing a succession plan because of the number of employees that will be retiring in the next 2-7 years.

Police Chief Adams informed the Council that he wished to install two radar signs along Hwy 275 to notify motorist how fast they are traveling. He has heard concerns about the increase in traffic through town upon completion of the Hwy 275 4-lane project. Each sign will cost \$3,720.00 and one would be funded with Cuming County STOP funds.

The next agenda item was to discuss the potential purchase of real estate. Moved by Swenson, seconded by Smith to go into closed session at 6:30 PM for the protection of the public interest to discuss the potential purchase of real estate. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried. The Mayor then restated for the record the limitation of the subject matter of the closed session was for the protection of the public interest to discuss the potential purchase of real estate. At 6:41 PM the Mayor stated that the closed session had ended and that the only item discussed during the closed session was the potential purchase real estate and that the Council was back in regular session.

Moved by Swenson, seconded by Smith, to adjourn at 6:42 P.M. Voting Yea: Stokely, Penrose, Swenson, Hugo, and Smith. Nay: None. Absent: Buse. Motion carried.
