MINUTES OF MEETING

A meeting of the Mayor and City Council of the City of West Point, Nebraska was convened in open and public session at 5:30 PM on December 6, 2022 in the Council Chambers at the Municipal Building, 444 S. Main Street, West Point, Nebraska.

Present were: Mayor Schlecht; Councilmembers: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Absent: None.

The Mayor called the meeting to order and stated that in accordance with State Statute Section 84-1412 the Open Meetings Act is posted on the west wall in the Council Chambers for public information. The Pledge of Allegiance was then recited.

Moved by Smith and seconded by Penrose to approve the minutes of the Council meeting held on November 1, 2022. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Penrose, seconded by Stokely, to accept the Certificate of Election as prepared by the Cuming County Clerk/Election Commissioner regarding the following positions:

Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The next agenda item was to consider the third and final reading of the ordinance concerning the increase in the salaries of the Mayor and Council. The mayor's salary increasing from \$6,000 to \$6,600 and the council's salary increasing from \$3,600 to \$3,960. Ordinance No. 1436 was read by title only:

AN ORDINANCE OF THE CITY OF WEST POINT, NEBRASKA FIXING THE SALARIES OF THE MAYOR AND MEMBERS OF THE CITY COUNCIL OF THE CITY OF WEST POINT; PROVIDING FOR NO INCREASE OR REDUCTION DURING TERMS OF OFFICE EXCEPT AS PROVIDED BY LAW; PROVIDING FOR THE FIXING OF COMPENSATION OF OTHER OFFICERS, OFFICIALS. AND EMPLOYEES; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE AND PROVIDING THE TIME WHICH THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

Hugo moved for final passage of the ordinance which motion was seconded by Swenson. Voting Yea: Swenson, Buse and Hugo. Voting Nay: Stokely, Penrose, and Smith. The result of the vote being a tie with 3 Yeas and 3 Nays. The Mayor then cast the deciding vote of yes and declared

Ordinance No. 1436 adopted.

Moved by Smith and seconded by Penrose to adjourn Sine Die. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

A reorganizational meeting of the Mayor and Council of the City of West Point, Nebraska was held at the Municipal Building in said City. Present were: Mayor-elect Schlecht; Councilmembers: Councilmember-elect Stokely, Councilmember Penrose, Councilmember Swenson, Councilmember Buse, Councilmember-elect Hugo, and Councilmember-elect Smith.

The newly elected Mayor and Councilmembers were then sworn in.

Election of council president was held. Swenson nominated Councilmember Hugo. Moved by Swenson and seconded by Smith, that the nominations cease and that Councilmember Hugo be elected Council President. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried. The Mayor declared Councilmember Hugo to be the Council President.

The Mayor then opened a public hearing to consider the application for a Class DK liquor license of BB Gas, LLC, dba Petro Mart. There were no comments from the public and no correspondence has been received. Moved by Swenson, seconded by Smith, to approve the application of BB Gas, LLC, dba Petro Mart for a Class DK liquor license at 226 S. Lincoln Street and that the Nebraska Liquor Commission be notified of this action. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Rick Wimer of Inspro Insurance reviewed with the Council the City's general insurance coverage/premium with Employers Mutual Casualty Insurance Companies. It was stated that the property values have increased slightly in part by adding the new playground equipment. Mr. Wimer also reviewed with the Council the cyber liability coverage from two companies. It was moved by Smith and seconded by Swenson, to continue the City's general property and casualty insurance coverage with Employers Mutual Casualty Insurance Companies and the cyber liability coverage with Cowbell Cyber. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Next the Council considered a request from David Knievel for the subdivision of real estate located in Lot 3, Block 105, in the City of West Point, also known as being in David Neligh's Addition to the City of West Point, Cuming County, Nebraska. When the house that was constructed on Lot 2, it encroached onto the neighboring property, being Lot 3. This lot split will remedy the situation. The City Administrator advised that the Planning Commission had considered the matter and was

forwarding a favorable recommendation. Smith introduced the following resolution and moved its adoption:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF WEST POINT, NEBRASKA, TO APPROVE A CERTAIN CONVEYANCE OF REAL ESTATE LOCATED WITHIN THE CITY OF WEST POINT, CUMING COINTY, NEBRASKA.

Buse seconded the motion. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried and said resolution adopted.

The Council then considered the Annual Maintenance Agreement between the Nebraska Department of Transportation and the City relating to the responsibilities/maintenance of the highways within the municipality. There was no change from the previous year in the lane miles being 3.94 lane miles or the cost per lane mile being \$1,545.00. Moved by Hugo and seconded by Smith to approve the Annual Maintenance Agreement for the period of January 1, 2023 to December 31, 2023. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried

Moved by Penrose and seconded by Swenson to appoint Councilmember Smith as the City's representative to the Cuming County Economic Development Board. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Stokely, seconded by Buse, to approve the application for a Special Designated Liquor Permit for St. Mary's Church for a Cornhole Tournament on Friday, January 6, 2023 at the GACC Activities Center. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

Moved by Smith seconded by Buse, to approve the claim of Tom Swenson Advertising for promotional items for the Nielsen Center in the amount of \$1,796.28. Voting Yea: Stokely, Penrose, Buse, Hugo, and Smith. Nay: None. Abstaining: Swenson. Motion carried.

Moved by Buse seconded by Smith, to approve the claim of Hugo Plumbing & Heating for services and supplies in the amount of \$1,365.36. Voting Yea: Stokely, Penrose, Swenson, Buse, and Smith. Nay: None. Abstaining: Hugo. Motion carried.

Moved by Smith and seconded by Swenson to authorize the Mayor to sign a Letter of Intent to the Nebraska Department of Economic Development for a grant from the Community and Civic Center Financing Fund Program in the amount of \$562,000 for the new Aquatic Center

Project. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.

The next agenda item being the approval of Application/Payment #1 to Christiansen Construction for the West Point Aquatic Center Project was passed over and no action was taken.

Moved by Smith, seconded by Swenson, to adjourn at 5:53 P.M. Voting Yea: Stokely, Penrose, Swenson, Buse, Hugo, and Smith. Nay: None. Motion carried.
